## Goods traffic with sensitive products

## Raw materials for explosives

In accordance with Regulation (EU) 2019/1148 and consolidated versions, we have been obliged since February 1, 2021 to check, within the framework of the due diligence required in the movement of goods, whether bans and restrictions on the placing on the market of the above-mentioned starting materials and the requirements regulated with regard to the supply of these starting materials are complied with.

As part of this obligation, we as the manufacturer, seller or distributor must request a declaration of use from the direct customer for certain products. This declaration confirms that these raw materials are only used in a permitted manner and are not passed on to third parties without authorization.

We would now like to ask you to complete the enclosed declaration of use and return it to us. Unfortunately, we can only process the shipping order once we have received and approved the declaration.
